- 2) I observed the name, address, and purported signature of my friend and supporter David Block, listed on page 11 line 1 of Ms. Daniels' nomination papers. I contacted Mr. Block and he informed me that he had not signed the nomination papers for Ms. Daniels.
- 3) Upon further review of the remainder of Ms. Daniels' signatures I noticed that pages 5, 8, 11, and 14 all contained very similar handwriting.
- 4) On June 2nd and 3rd, I attempted to contact all of the individuals listed on pages 5, 8, 11, and 14 of the nomination papers.
- 5) Fifteen of the people I made contact with stated they did not sign Ms. Daniels' nomination papers and agreed to sign an affidavit stating as much.
- 6) Seven of the people I made contact with told me they did not sign Ms. Daniels' nominations papers, but declined to sign an affidavit.
- 7) Five of the individuals I contacted indicated they did not sign the nomination papers and would attest to that fact, but I did not have a notary available to take a sworn statement at that time.
- 8) One of the addresses (530 Brookstone Way, Watertown) listed next to a signature was a vacant lot which did not contain a residential dwelling. (Page 11, Line 6)
- 9) According to Mr. and Mrs. Buss, who reside at 804 East Cady St appearing on page 14 of the nomination papers, the woman listed on line 7 of page 14 does not reside in that residence.
- 10) Another individual I spoke with stated that she rented from the person listed on the nomination papers but the person's whose signature appears on the nomination paper did not reside there. Furthermore, she stated the person listed in the nomination papers was vacationing in Hawaii on the date he is listed as signing Ms. Daniels' nomination papers. (Page 11, Line 3)
- 11) Mr. and Mrs. Joyce, listed on page 14, told me they did not sign and the woman listed on line 3 of that page, Amanda Grace, does not reside at that address and hasn't lived at that address for over a year.
- 12) In total, I made contact with 28 of the individuals whose names were included on pages 5, 8, 11, and 14 of Ms. Daniels' nomination papers; all of them confirmed to me personally that they did not signed Ms. Daniels' nomination papers. In fact, in my

investigation not a single person I contacted had actually signed Ms. Daniels' nomination papers.

13) My notes and observations from contacting the individuals on pages 5, 8, 11, and 14 are attached; they are a true and accurate reflection of my findings to the best of my knowledge.
