**CURRENT SITUATION – NOTE: CHANGE IN DATE OF BURN (See Below)** 

Planning has continued over the last several days for the thermal destruction of the apartment building at 109 Knaup Drive in Beaver Dam, WI. The original planned date of Wednesday March 14<sup>th</sup>, has been moved to Thursday March 15<sup>th</sup> due to weather forecasts of strong winds for Wednesday. All plans and technical approaches remain the same for Thursday.

Current operations for Tuesday March 13<sup>th</sup> (today) will continue, and include general site preparation and readiness for the day of the burn. New operations today will now include verification of all resources and verification of schedules. The City EOC will remain open and we will add an additional day of the burn. Current planned press conferences will continue as scheduled.


**Beaver Dam** – At a planning meeting this morning an update was provided by the National Weather Service indicating that wind speeds for Wednesday were not expected to be favorable for a safe operation. Weather conditions are expected to improve for Thursday. Therefore, the planned burn has been postponed until Thursday, March 15, 2018. All of the times remain the same. Roads will be closed starting at 9:00 a.m. Thursday.

The media are invited to attend a briefing about the Village Glen Apartments Render Safe Operation in the Beaver Dam City Council Chambers (205 S Lincoln Ave, Beaver Dam, WI 53916) at **4 pm on today**.

No new information is anticipated to be shared beyond what is being shared here regarding postponing the burn due to weather. Mainly this is an opportunity for the media to ask questions and conduct individual interviews with officials. Unfortunately, we are not able to accommodate individual requests for interviews throughout the day today. If you have needs, please attend the media briefing at 4 pm today.

The controlled burn of Village Glen Apartments Building 109 has been postponed until Thursday, March 15<sup>th</sup> due to a change in the forecast weather conditions. The times will remain the same.

## INCIDENT INFORMATION March 13, 2018

### **New Information:**

- Date of burn changed to Thursday, March 15, 2018
- Transportation to St. Katherine's is available for those who are in the mandatory evacuation notice who have no other means of travel. If you want transportation, call the EOC at 920-887-4600 ext 250 or 241 by Wednesday at noon.
- Part of Building 123 also falls within the mandatory evacuation zone.

### **BACKGROUND**

- On March 5<sup>th</sup>, the Beaver Dam Police and Fire Departments responded to an explosion at the Village Glen Apartments, Building 109. A small fire was extinguished and a deceased male was discovered in one of the apartments.
- Responding agencies discovered a number of hazardous chemicals in the apartment where the explosion occurred. Numerous state and federal agencies were called in to investigate.
- Due to the volatile nature of the chemicals that were found in Building 109, it has been permanently evacuated. No one is allowed to enter this building, including all agency personnel.
- It was determined that the safest way to mitigate the risk from the chemicals in the apartment is through "thermal destruction" which means we plan to intentionally burn building 109. It is the heat that will be generated by this fire which will render the situation safe.

### PLANNED OPERATIONS

- We are planning the intentional structure burn of Building 109 for Thursday, March 15, 2018.
- At 9:00 a.m. on Thursday morning, the outer perimeter will be closed to traffic (see map on last page). No civilian traffic will be allowed to enter after this time.
- We are doing a mandatory evacuation for those nearest Building 109 as per the
  recommendation of the FBI. This will affect residents living in Buildings 103, 105, 107,
  111 and 113. It also affects part of Prairie Ridge, Keystone Manor and Village Glen
  Apartment 123. It is acceptable for people to shift internally within their building to get
  them out of the inner zone of concern.

# BEAVER DAM

### GE GLEN APARTMENT RENDER SAFE OPERATION

- All other residents and businesses in the area of the Village Glen Apartments (within the area of Knaup Dr., N. Spring St. from Woodland Dr. to Industrial Dr. E., and Industrial Dr. E. to but not including HWY 151) are recommended to evacuate or shelter in place.
   Shelter in place means to seek safety within the building one already occupies. All windows and doors should be closed and all people and pets should stay inside.
- Around 10:00 am, Building 109 will be intentionally ignited.
- The goal is to complete the burn and allow activity to resume in the area by evening.
- When the closure is lifted, it will be posted on the Beaver Dam Police Department Facebook page.

### FOR RESIDENTS UNDER MANDATORY EVACUATION

- Please leave the closure area by 9:00 a.m.
- Law enforcement will do building checks at 9:30 a.m. to make sure that all residents have evacuated.
- During the time you are evacuated, you are welcome to stay at the St. Katherine Drexel Parish Center, which is our Family Assistance Center. St. Katherine's will be open starting at 8:00 a.m. You can come and bring your pets and spend the day there. Food and water will be provided. Counselors will be on hand.
- Everyone who is evacuating the area needs to take purse, pills, pets, pet food, pet
  carriers, phones, and valuables with them when they leave. Once you leave the area,
  you will not be allowed to reenter even if you forgot something and emergency workers
  will also not go in after something you left behind. Please plan accordingly.
- Please note that you are responsibility for your pets at St Katherine's. Only domestic pets will be allowed.
- We do not anticipate this going overnight, but if it does St Katherine's will also serve as an overnight shelter.
- Residents in the evacuated area will need to have a plan in place for the end of their day. You will not be able to return to your property until the closure is lifted (anticipated for evening). St. Katherine's will be available to you.
- For those in the evacuation area, school buses will drop off your kids in the afternoon at St. Katherine's.
- If you live in Building 113, we ask that you remove firearms and ammunition before Thursday. If you have any questions about your specific situation, please contact the Emergency Operations Center phone line listed later in this document.

A mandatory evacuation is required for all residents of Village Glen Apartments (including buildings 103, 105, 107, 111, 113 and 123) during the planned burn of Building 109 on Thursday March 15, 2018. Please leave the closure area by 9:00 am. When you leave your apartment in the morning, take your purse, pills, pets, phones and valuables with you. If you forget something, you will not be allowed to return. Safety officers and police will be going door to door at 9:30 am to confirm residents have left. The burn is scheduled to start at 10:00 am. Note that once you leave the area you will not be allowed to return until the area is deemed safe. School buses will drop off students in the afternoon at St. Katherine's. The goal is to complete the burn and allow residents to return home by evening. During the time you are evacuated, you are welcome to stay at the St Katherine Drexel Parish Center at 408 South Spring, which is our Family Assistance Center. You can come and bring your pets and spend the day there. Please note that you will be responsible to control your pets at St, Katherine's. Only domestic pets will be allowed. Food and water will be provided. We do not anticipate this going overnight, but if it does St Katherine's will also serve as an overnight shelter. When roads are reopened, it will be indicated on the Beaver Dam Police Department Facebook page and announced at the St. Katherine Drexel Parish Center.







The sea container barriers will be being placed tomorrow. All persons working in the area should be aware of both activities. Since heavy equipment will be involved in container placement, check in with on site crews before working in this area.

Division and Group Supervisors, Command and General Staff and Safety Officer as well as agency staff are invited to an operations briefing (ops brief) at 0600 on March 14th, 2018.

The attached does not include the post burn plan, or the re-entry plan. These are available at the EOC if required.

MADISON, Wis. - The chemical found in a Beaver Dam apartment is the explosive TATP, News 3 has learned.

Robert Thiboldeaux, Senior Toxicologist with the Wisconsin Division of Public Health told News 3 that first responders on scene in Beaver Dam have shared that the explosive <u>triacetone triperoxide</u>, also known as TATP, is what was found in the Knaup Drive apartment building.

"We've been told that the explosive TATP was found on site," Thiboldeaux said in an interview Tuesday. "There was a person occupying one of these apartments that was doing something with this material. Local first responders got involved and at that point they've decided that they can't safely remove this material."

When asked at a news conference Tuesday afternoon, Beaver Dam fire chief Allen Manned said he could not confirm that TATP was on scene and Beaver Dam police chief John Kreuziger told News 3 he couldn't discuss what was inside the building.




Thiboldeaux say the explosive is highly sensitive to being moved or tested in the field.

Officials in Dodge County have said they believe the chemicals found in the apartment can only be eliminated by burning the building down. That burn was scheduled for Wednesday, but was moved to Thursday because of concerns about high winds. Thiboldeaux tells News 3 that state fire-fighting experts believe there will be no unusual hazards to the public in the air.

"The explosive itself, we expect that to be consumed in the fire. So that's not really an issue," Thiboldeaux said. "The issue really is this will be a fire that produces smoke just like any other building fire."

Thiboldeaux says the public should follow instructions of the fire department, and those with pre-existing conditions should check with the Dodge County Health Department or their doctor to see about any concerns for exposure to smoke.

Thiboldeaux also tells News 3 the Environmental Protection Agency will be on hand to monitor the air and clear residents in Beaver Dam to return to apartments in the area.

TATP was reportedly used in the bombs in the Paris attack in 2015, and New York Central Park explosion in 2016, according to published reports.

Officials in Beaver Dam have said they believe there is no link to terrorism.

### Post Burn Planning

### Step One:

Initiate Sampling of Ash and debris as soon as safe and practical after burn pile cools to determine if ash is energetic following the disposition classification system of treated materials.

- · Philosophy of 0, X 3X, 5X classification system
  - Army Industrial Operations Command IOC 385-1
  - P&W Work Instruction 231.07.67, Classification and Decontamination of Explosive Facilities and Equipment
  - Tagging certification and documentation

### X, 3X, 5X, and 0 Definitions

- X or 1X Routine cleaning
  - Such as end of work day
  - Contamination may be visually detectable
  - Transported only in live area by qualified personnel
  - Further cleaning needed for major maintenance or repair
  - Cannot be sent outside the live area without further decontamination and reclassification
- XXX or 3X Surface contamination removed
  - Visual surface contamination removed
  - Some contamination may be detectable with indicator solutions
  - Significant reactive material may remain in less obvious places
  - Safe for routine maintenance, and careful disassembly (following written procedures accounting for specific hazards)
  - Don't subject to welding, drilling, sawing, etc that may ignite residual contamination

- Not safe for sale to general public

If Ash is still energetic 1x- to 3x = Chemical Treatment using contractor. Maintain security watch and fence until plan can be developed.


If Ash is determined energetically safe = 5x or zero, a determination is then needed as to disposal suitability. Maintain security until Law Enforcement is done collecting evidence. Complete search of surrounding areas to ensure no post blast debris is evident. Once completed have City Attorney draft a property release to owner. WDNR Solid Waste should be notified to work with property owner on waste disposition. We recommend the city not be party to any waste disposal.

Step Three: After Ash removal remove fence.
