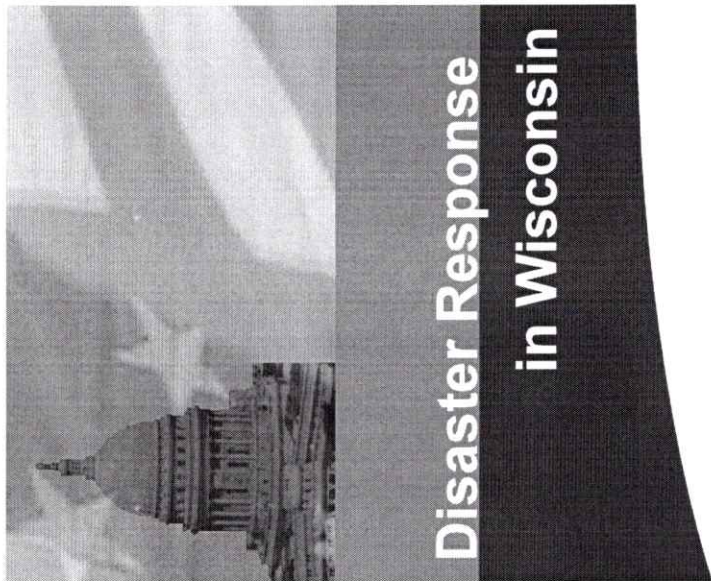

Types of Disaster Assistance

All requests for assistance must be coordinated through the county emergency management office to Wisconsin Emergency Management.

State Assistance

For local and tribal units of government only.

■ The Wisconsin Major Disaster Assistance Fund makes \$3 million available annually to assist local and tribal governments who have been impacted by a disaster that is turned down for federal disaster assistance or does not meet the federal thresholds. Grants (cost-share of 70% state and 30% local) are for costs related to debris clearance, emergency protective measures (erecting barricades, search and rescue and emergency pumping) and road damage.

Federal Assistance

For the Public Sector (local, tribal and state governments and private, not-for-profit agencies that provide an essential government service, such as a rural electric cooperative).

■ Public Assistance Grants (cost-share of 75% federal, 12.5% state and 12.5% local in most cases) to repair or replace uninsured publicly-owned facilities and equipment that have been damaged by a disaster. Examples are roads, streets, bridges, municipal buildings, water treatment facilities, etc. Grants are also available to help recoup emergency response costs incurred immediately after a disaster. These may include such costs as debris removal, erecting barricades, search and rescue and emergency pumping.

■ Hazard Mitigation Grants (cost-share 75% federal, 12.5% state and 12.5% local) to develop hazard mitigation plans or project grants to fund long-term mitigation measures. Project grants must result in cost-effective hazard reduction. Priority is given to protection of critical infrastructure and substantially damaged structures or structures that have suffered repetitive losses.

For the Private Sector (Individuals, Farmers, Businesses)

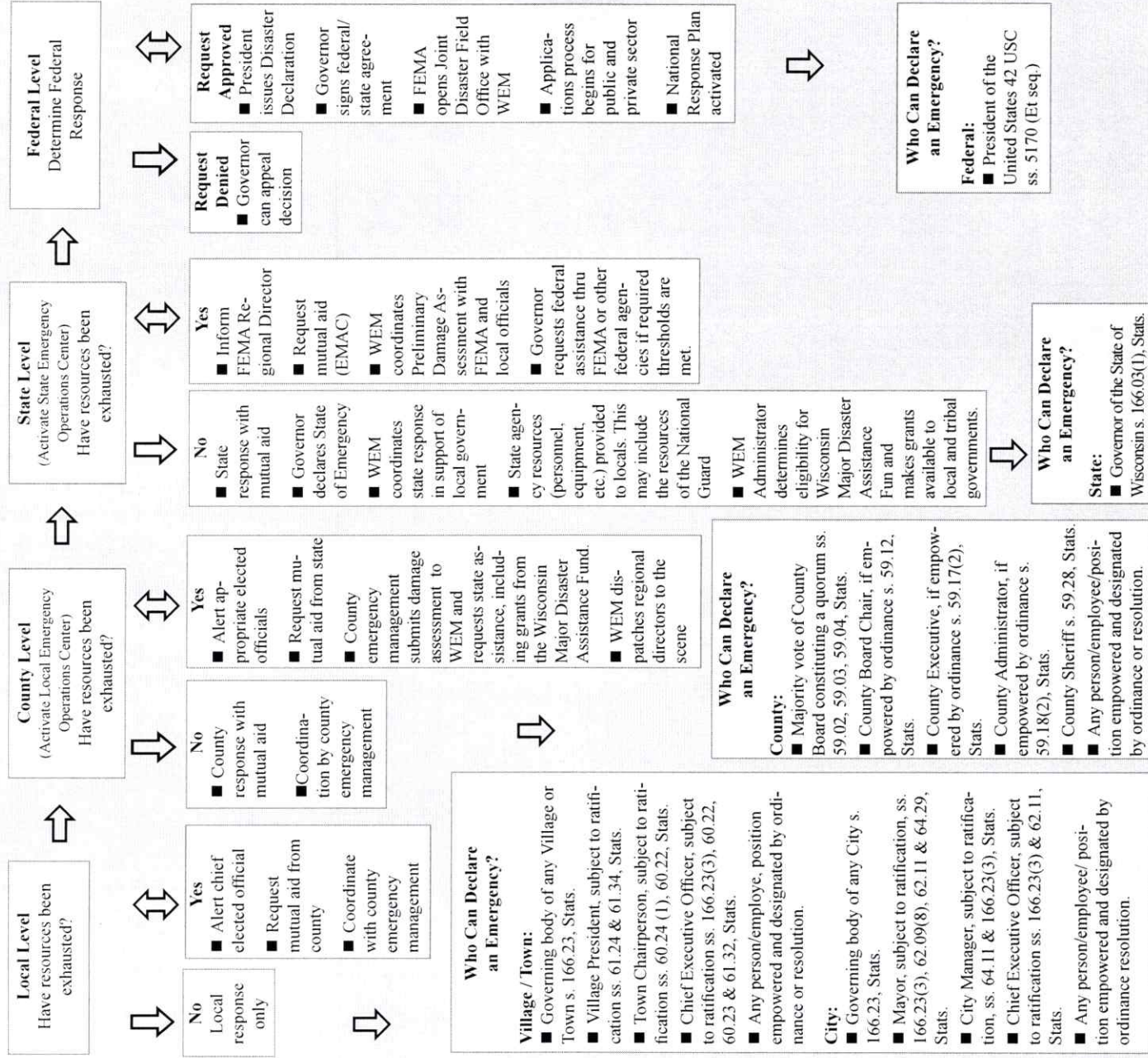
■ **Disaster Housing Grants** to make minor repairs to homes where there is no insurance coverage or to help pay for temporary housing costs while displaced from a disaster-damaged residence.

■ **Small Business Administration Loans** (low-interest) to help homeowners, renters and businesses recover from real and personal property losses related to a disaster event. Economic injury loans are also available for qualified business owners.

■ **Other Needs Assistance Grants** to help with uninsured disaster related losses such as replacing or repairing essential personal property, medical/dental costs, and funeral expenses. Only for individuals who are not eligible for loan assistance.

■ **Farm Service Agency Loans** (low-interest) to assist with physical and production losses incurred by farm producers and agri-businesses that have been impacted by a disaster.

NOTE: Under 323.14(4)(b), Stats., this proclamation shall be subject to ratification, alteration, modification or repeal by the governing body as soon as that body can meet, but the subsequent action taken by the governing body shall not affect the proper validity of this proclamation.



WHO CAN DECLARE AN EMERGENCY?

STATE

- ◆ Governor §166.03(1), Stats.

COUNTY

- ◆ Majority vote of County Board constituting a quorum §§59.02, 59.03, 59.04, Stats.
- ◆ County Board Chair, if empowered by ordinance §59.12, Stats.
- ◆ County Executive, if empowered by ordinance or law is subject to enforcement by county executive or any person supervised by the county executive §59.17(2), Stats.
- ◆ County Administrator, if empowered by ordinance or law is subject to enforcement by county administrator or any person supervised by the county administrator §59.18(2), Stats.
- ◆ County Sheriff § 59.28, Stats.
- ◆ Any person/employee/position empowered and designated by ordinance or resolution.

CITY

- ◆ Governing body of any City §166.23, Stats.
- ◆ Mayor, subject to later ratification, alteration, modification or repeal by governing body §§166.23(3), 62.09(8), 62.11 & 64.29, Stats. (Includes City Commission Plan)
- ◆ City Manager, subject to later ratification, alteration, modification or repeal by governing body §§64.11 & 166.23(3), Stats.
- ◆ Chief executive officer or acting chief executive officer, subject to later ratification, alteration, modification or repeal by governing body §§166.23(3) & 62.11 Stats.
- ◆ Any person/employee/position empowered and designated by ordinance or resolution.

VILLAGE

- ◆ Governing body of any Village §166.23, Stats.
- ◆ Village president, subject to later ratification by village board §§61.24 & 61.34, Stats.
- ◆ Chief executive officer or acting chief executive officer, subject to later ratification, alteration, modification or repeal by governing body §§166.23(3) & 61.32 Stats.
- ◆ Any person/employee/position empowered and designated by ordinance or resolution.

TOWN

- ◆ Governing body of any Town §166.23, Stats.
- ◆ Town Chairperson subject to later ratification by town board §§60.24(1) & 60.22, Stats.
- ◆ Chief executive officer or acting chief executive officer, subject to later ratification, alteration, modification or repeal by governing body §§166.23(3), 60.22 & 60.23 Stats.
- ◆ Any person/employee/position empowered and designated by ordinance or resolution.

Re: Knaup Drive

The following information is for Department dissemination only at this time. The contents should not be discussed to anyone outside the department except for one piece of information that will follow.

1. 109 Knaup Scene security – no one shall be allowed inside the fence surrounding building 109
2. Residents of the 109 building were allowed to retrieve property from their rented garages today. One resident of apt. #16 still has a lot of property to remove, which might be allowed in the next couple of days. 503 will handle this.
3. The City of Beaver Dam has declared a “State of Emergency” for building 109.
4. We will be providing at least 2 officers for building 109 as scene security until Wednesday, March 14th.
5. An official posting for manpower will soon be posted for the available shifts on Tuesday March 13th and Wed. March 14. Everyone available for Wednesday is encouraged to sign up. At this time we are not limiting the number of officers willing to work on Wednesday afternoon and evening, Because.....
6. Plans have started to safely mitigate the hazards associated with the 109 building. This includes a “burn in place” operation. This is being coordinated primarily by BDFD. This is tentatively scheduled for Wednesday afternoon into the evening. Planning will continue at 9am on Saturday at the FD, in case anyone asks you how to get to the FD from other agencies or Fire type people.
7. Because many non-residents of the Village Glen apartments were driving in, to have a look-see of the area, we assigned a driveway security position to only allow residents to enter their private road and complex. The residents were grateful for this part of the operation. We will continue to try this during the next few days by utilizing BDPD Auxiliary. This cannot be done 24-7, however we will try to do it during the daylight hours.
8. Info. That is for public knowledge..... A community meeting is scheduled to occur at 6pm on Monday, March 12th, at the High School auditorium. All of the community is invited to receive further knowledge of what to expect going forward, with this state of emergency for the 109 building and surrounding area. All residents of Village Glen apartments, surrounding apartments, and businesses are encouraged to attend this meeting.

This email is to request the following records under Wisconsin Open Records Law (Wis. Stat. § 19.31-39):

- We are looking to request a search warrant for the entire building and garages for 109 Knaup Drive, Beaver Dam. On Monday March 5, 2018 at about 12:56 pm Dodge County Central Communications received a 911 call of an explosion that took place at the above listed address. It is confirmed that one person has died as a result of the incident. The incident itself is still under investigation

Please be aware that the Open Records Law defines "record" to include information that is maintained on paper as well as electronically, such as data files and unprinted emails. Wis. Stat. § 19.32(2).

If you deny my request, please do so in writing and state what part of the law you believe entitles you do so. Wis. Stat. § 19.35(4)(a). Should any material become available before the rest is completed, please send them individually as they are ready.

As this request is made as a matter of public interest, I ask that all fees be waived. If you are unable to do so, please advise me if the total cost will exceed \$50.

I would prefer electronic records be emailed if possible. If that is not possible I can pick up hard copies in person.

If you have a question or require clarification, please contact me as soon as possible. In accordance with the Law, I request a reply or my requested records" as soon as practicable and without delay."
